

Proceedings for enlargement of Flashing Ohio

Ordinance

An Ordinance authorizing the enlargement of the Corporate Limits of the Village of Flashing Ohio and the annexation of certain contiguous territory thereto. Dec 1. Be it ordained by the Council of the Village of Flashing Ohio a majority of (all the Members elected to said Council voting therefor) that the annexation of certain territory hereinafter described and the same being contiguous to the present corporate limits of said Village be authorized to wit: the same being a portion of the Township of Flashing Belmont Co Ohio and being a part of Section No 20 Township No 9 Range No 5 bounded and described as follows. Beginning for the same at the N W Corner of Sec 20 and following the North boundary line of said Section East 69.80 chains thence South 25.33 chains; thence West 9.80 chains; thence South 16.30 chains to the half section line thence West 60 chains to Section line; thence North 41.63 chains to the place of beginning containing Two Hundred and Twenty Five (225) Acres. Exclusion of the land contained within the present Corporate limits of Flashing Ohio to wit: Here as shown by the Record of Plat of Flashing Ohio filed in the Recorder's Office in Vol 10 Page 473. Dec 2. That J. W. Hollingsworth is hereby appointed and instructed to prosecute in the name of the said Village of Flashing Ohio all proceedings necessary to secure said annexation in the manner and form prescribed by the Statute of Ohio relating thereto. Dec 3. The Clerk is hereby directed and instructed to prepare a duly authenticated Copy of this Ordinance, and of all other proceedings of this Council showing its action thereon, and all plats and reports of Survey. Copies, originals of the same as may be or are required in the application for said annexation. Dec 4. This Ordinance shall take effect and be in force from and after its passage and legal publication. Passed January 31st 1887. J. W. Hollingsworth Clerk, Joseph H. Shannon Mayor.

Petition To the Honorable Board of Commissioners of Belmont County Ohio.

The Incorporated Village of Flashing Ohio by J. W. Hollingsworth its Agent, specially authorized and directed by the ordinance hereinafter mentioned, to act for it in the matter of this petition, respectfully represents that by an ordinance passed on the 31st Day of January A.D. 1887 by the Council of said Incorporated Village a majority of all the members elected to said Council voting therefor; it was ordained that the annexation of certain territory therein described, contiguous to the present corporate limits of said Village be authorized to wit: The same being a portion of the Township of Flashing Belmont County Ohio and being a part of Section No 20, Township No 9, Range 5, bounded and described as follows, beginning for the same at the N W Corner of Sec 20 and following the North boundary line of said Section East 69.80 chains; thence South 25.33 chains; thence West 9.80 chains; thence South 16.30 chains to the half section line; thence West 60 chains to the Section line; thence North 41.63 chains to the place of beginning containing two hundred and twenty five (225) acres, exclusion of the land contained within the present corporate limits of (said Village) Flashing Ohio to wit: Here as shown by record of Plat of Flashing Ohio filed in the Recorder's Office and recorded in Vol 10 Page 473. A duly authenticated Copy of said Ordinance is hereto attached and marked Exhibit "A". It is further represented that a Survey of the territory proposed to be annexed and hereinafter described has been made and an accurate plat thereof showing the present corporate limits of said Village, the boundary of the territory sought to be annexed to said Village, the several tracts or parcels of land within the same with the names of the respective owners thereof marked thereon which said Plat is hereto attached and marked Exhibit "B". It is therefore asked that this petition be filed in the Office of the County Auditor, and that a time and place be fixed for hearing of the same and give order and direction as to Notice therefor, and that upon the final hearing the prayer of this petition as here presented for the annexation of said territory and the extension and establishment of the Corporate boundary and limits of said Village in conformity thereto be granted, and for such other and further order as may be necessary to secure, confirm and establish such annexation legally and properly.
