residing within the hereinafter described Territory hereby petition your Honorable Bodies for permission to organize therein a Municipal Corporation under the Laws of Ohio and respectfully represent

First: That the following is an ^{accurate} description of the Territory embraced within the proposed corporation ab- situated in York Township in said County of Belmont and State of Ohio to-wit: bounded as follows: Begin nine at low water mark on the west bank of the Ohio River where intersected by the south boundary line of fractional section seven (7) Township 4 Range 3 thence west and with the south boundary line of said section seven (7) and section thirteen (13) same T^w. and Range to the S. W. corner of said section thirteen (13) thence North with the west boundary of said Section (13) to the N. W. corner of the Land of Fred Ramer thence east with the north boundary line of the said Fred Ramer to the West boundary line of the lands of Samuel Abrey thence north on the line between the lands of Samuel Abrey and Nicholas Annan to the S. W. corner of the lands of J. L. Widman thence with the South and East boundary lines of said J. L. Widman's land to the N. W. corner of the said Abrey; thence east with the North boundary line of said Abrey's Land to the East boundary line of said section 13 thence thence with north and on line between the lands of the heirs of G. W. Wood, deceased and J. W. Ramsey a distance of 792 ft to a stone at the N. W. corner of the lands of the heirs of the said G. W.
