

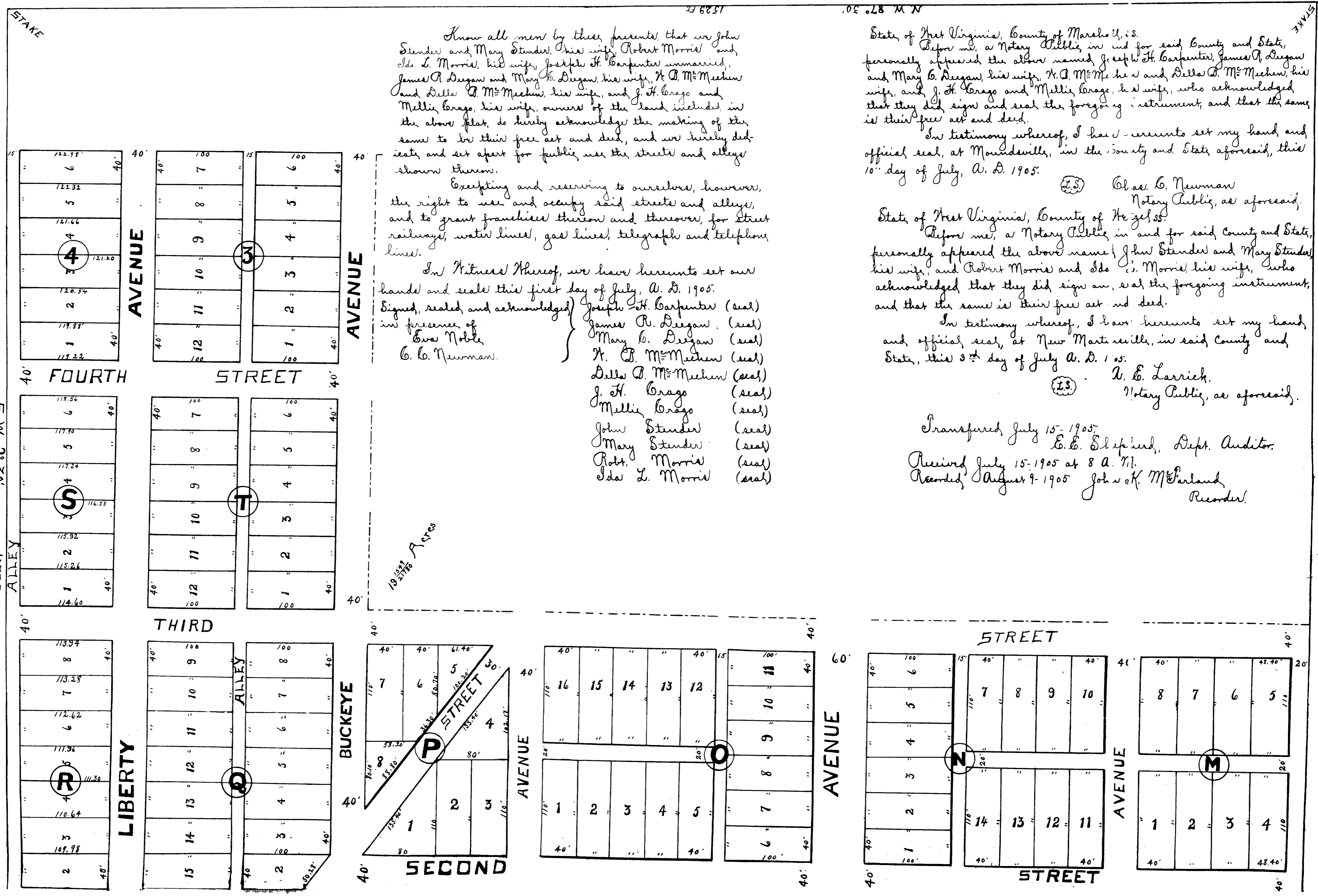
CAB. B - SLIDE 211
