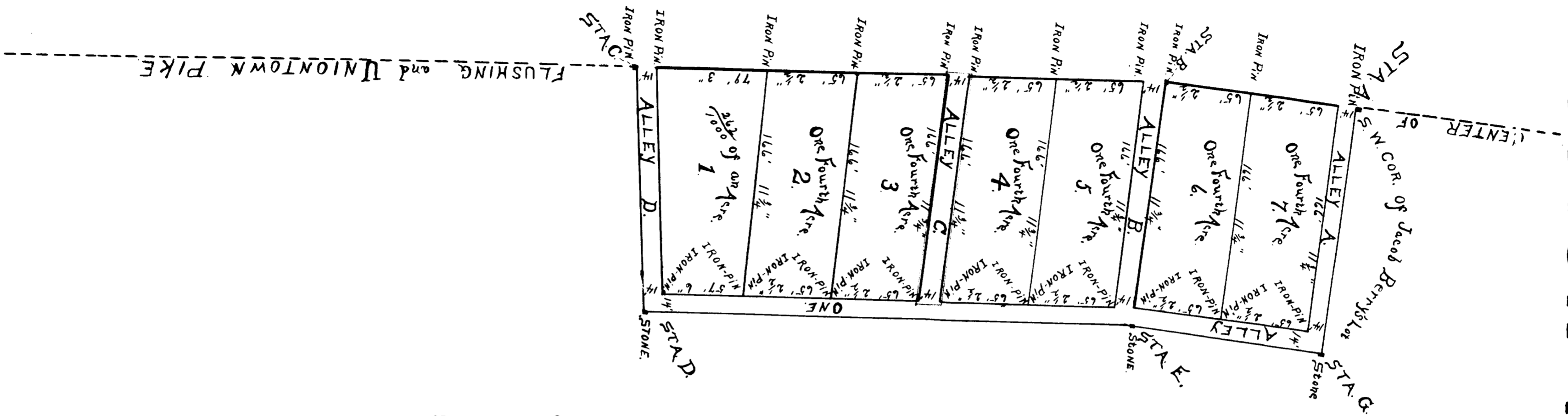


P. B. CALDWELL'S ADDITION TO BANNOCK.
