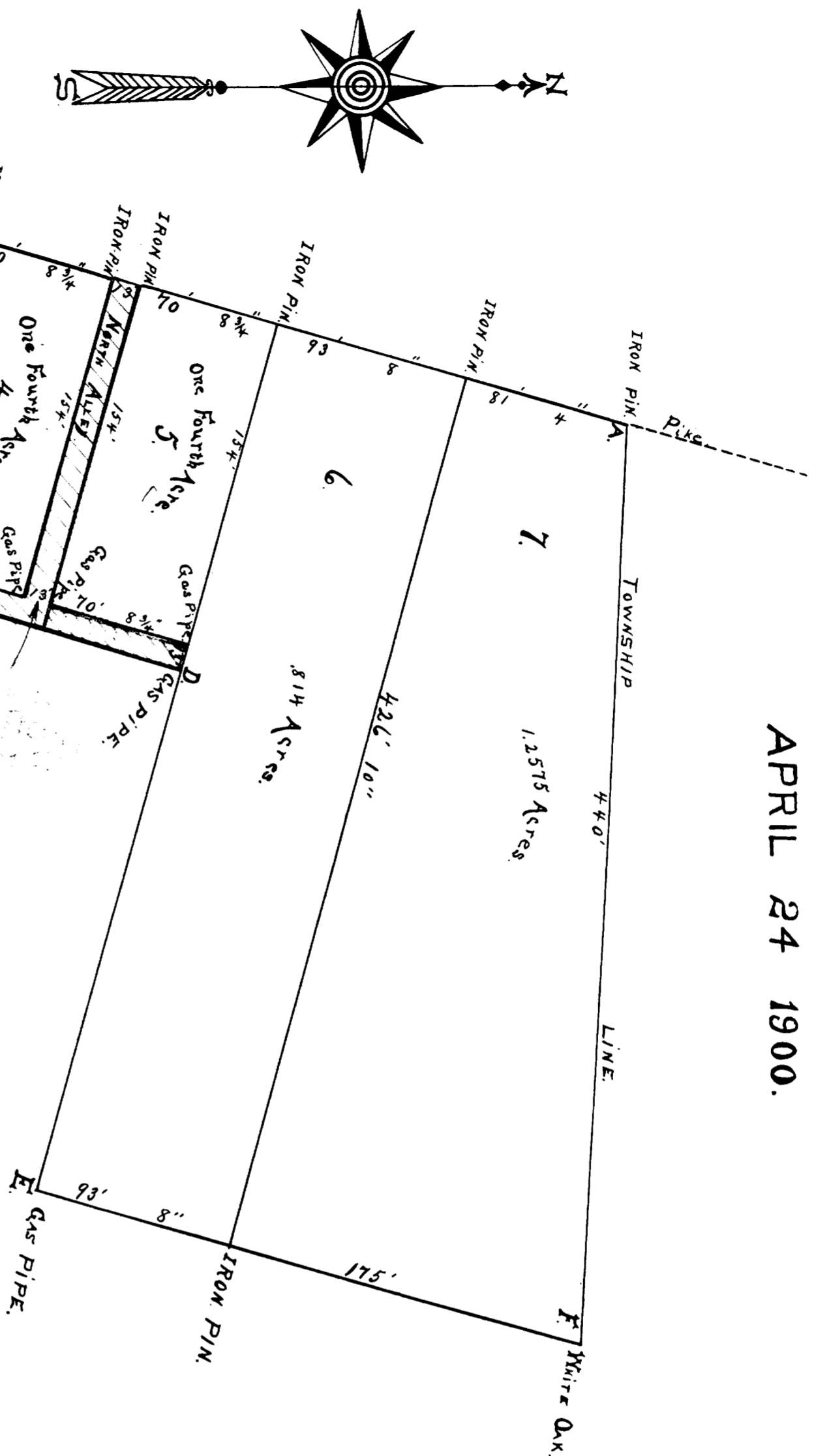


P. B. CALDWELL'S

Beginning at an iron pin in center of the Uniontown and Shading
 Pike at Sta. D. thence S. 16° 45' N. 567' 7 1/2" along the center of said Pike to
 Sta. A. and the S. N. Cor. of South Alley and the N. N. Cor. of the Parkway thence S. 16° 45' N. 70' 20' E. 168 ft. 1/2 inch along the south side of the Parkway to Sta. B.
 Lot 1 thence S. 70° 20' E. 168 ft. 1/2 inch along the south side of the Parkway to Sta. B.
 and S. E. Cor. of said alley; thence S. 16° 45' E. 410 feet 10 inches to a gas pipe at Sta. C.
 on the N. E. Cor. of East Alley; thence S. 73° 15' E. 257 feet 10 inches along the South
 boundary of Lot No. 6 to a gas pipe at Sta. E.; thence N. 16° 45' E. 268 feet 8 inches
 along the East boundary of Lots Nos. 6 and 7 to Sta. G. the South edge of a white
 oak tree 36 inches in diameter; thence N. 86° 00' N. 440 feet along the boundary
 line to the beginning containing 3.5796 Acres.
