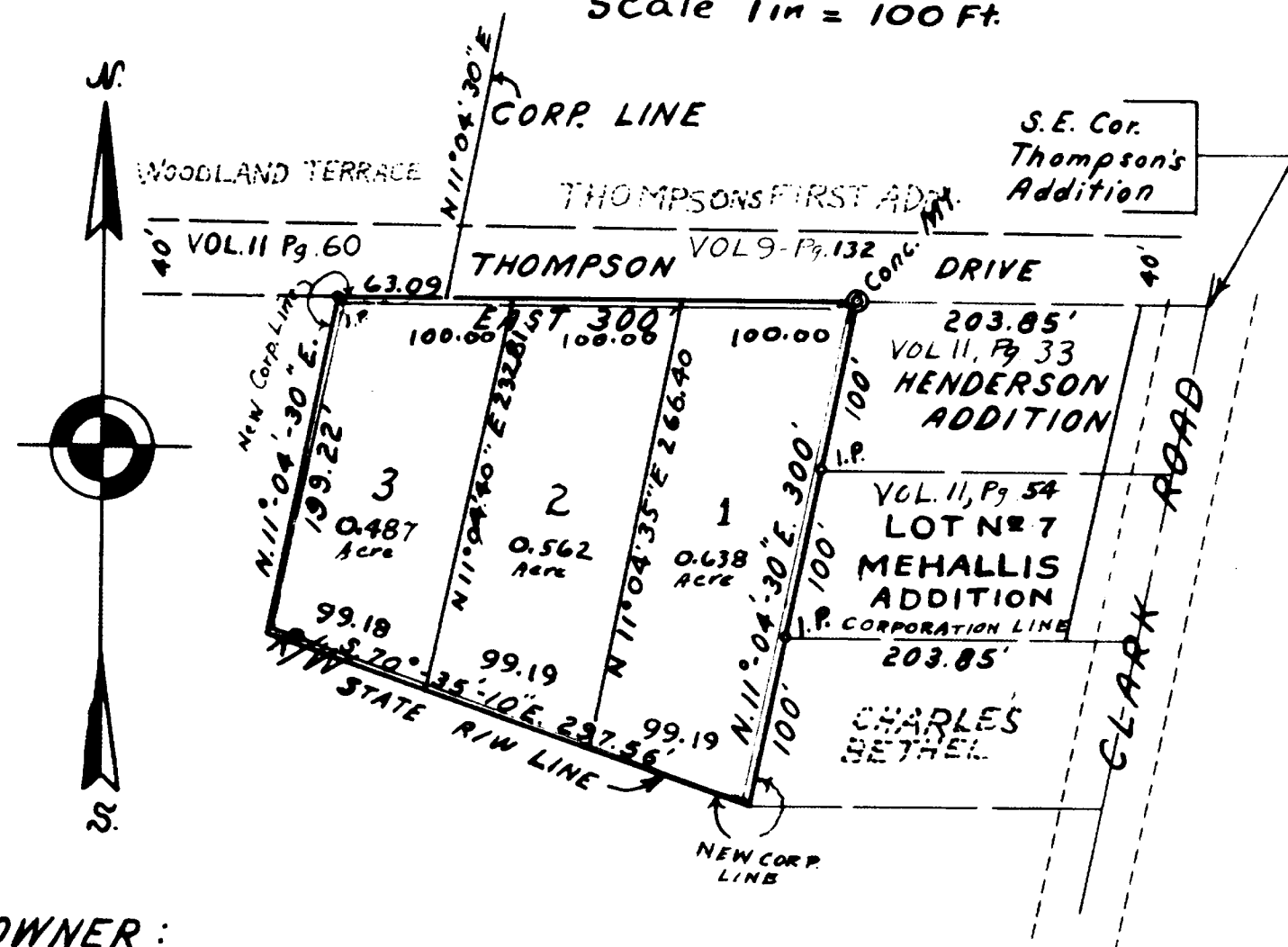


HENDERSONS SECOND ADDITION TO ST. CLAIRSVILLE-OHIO
