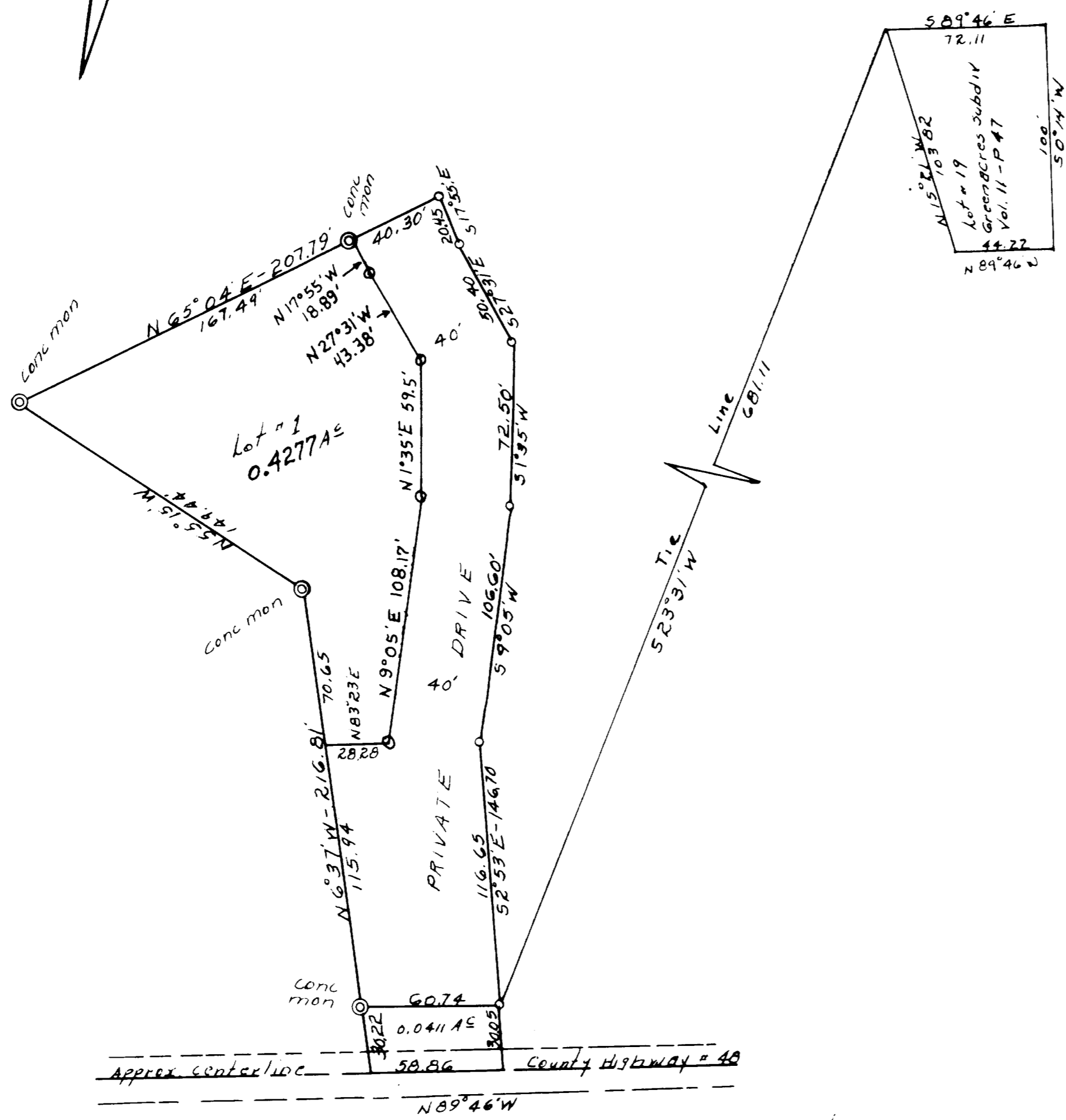


Note:

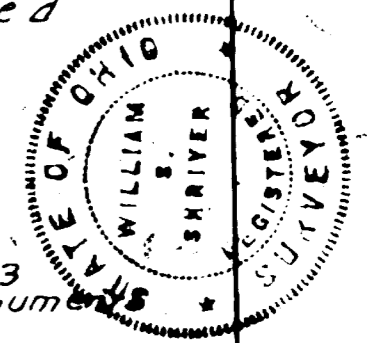
