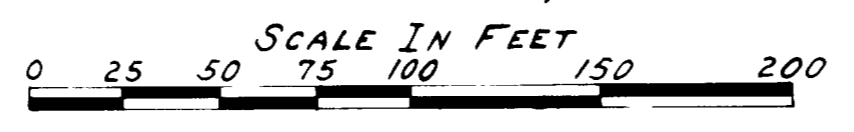


ORDINANCE No. 915

# VACATION OF A PART OF CHERRY LANE

BLOCK "B" ROSELAWN ADDITION TO ST. CLAIRSVILLE, OHIO  
RICHLAND TOWNSHIP, SECTION 4, T.7, R.3  
BELMONT COUNTY, OHIO



**DESCRIPTION:**  
Situating in the Village of St. Clairsville, Belmont County, Ohio. Beginning at the South West Corner of Lot 23 in Block "B", (ROSELAWN ADDITION) as recorded in Plat Book 5, Pg. 63 Belmont County Recorders Office. Thence along the South Line of Lot 23, N.54°-30' E. 125.00 Ft. to the South East Corner of Lot 23, where it intersects the West Line of Park St. and the North Line of Cherry Lane; Thence along the West Line of Park St. S.35°-30' E. 15.00 Ft. to the North East Corner of Lot 22 where it intersects the West Line of Park St. and the South Line of Cherry Lane; Thence along the North Line of Lot 22, S.54°-30' W. 125.00 Ft. to the North West Corner of Lot 22 where it intersects the East Line of Walnut Lane and the South Line of Cherry Lane; Thence along the East Line of Walnut Lane, N.35°-30' W. 15.00 Ft. to the place of beginning. Containing 0.043 Ac.
