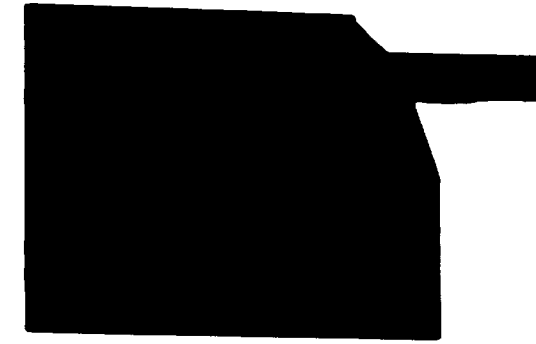


**MAP

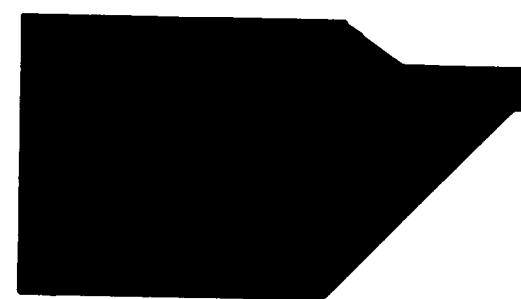

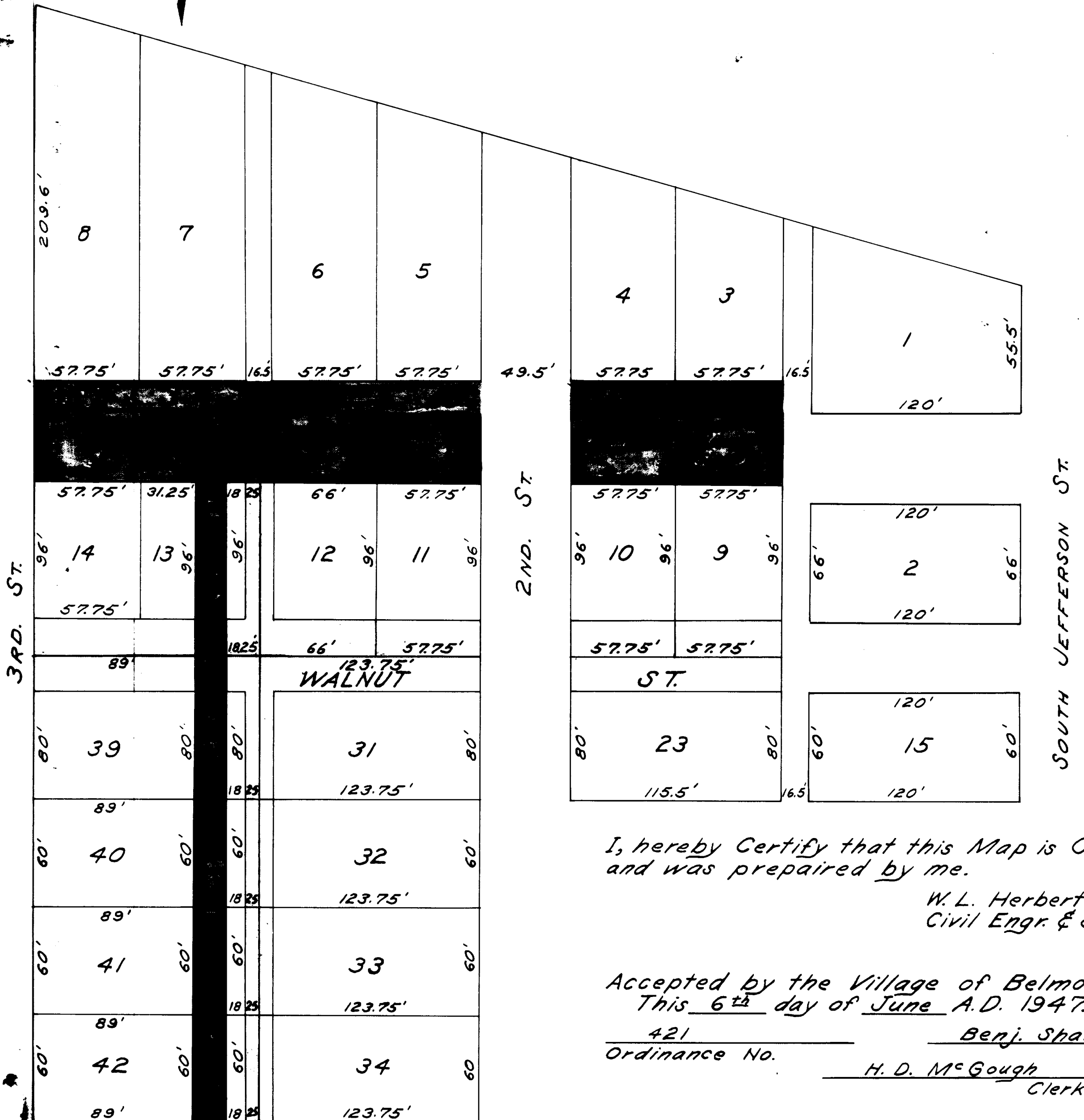
