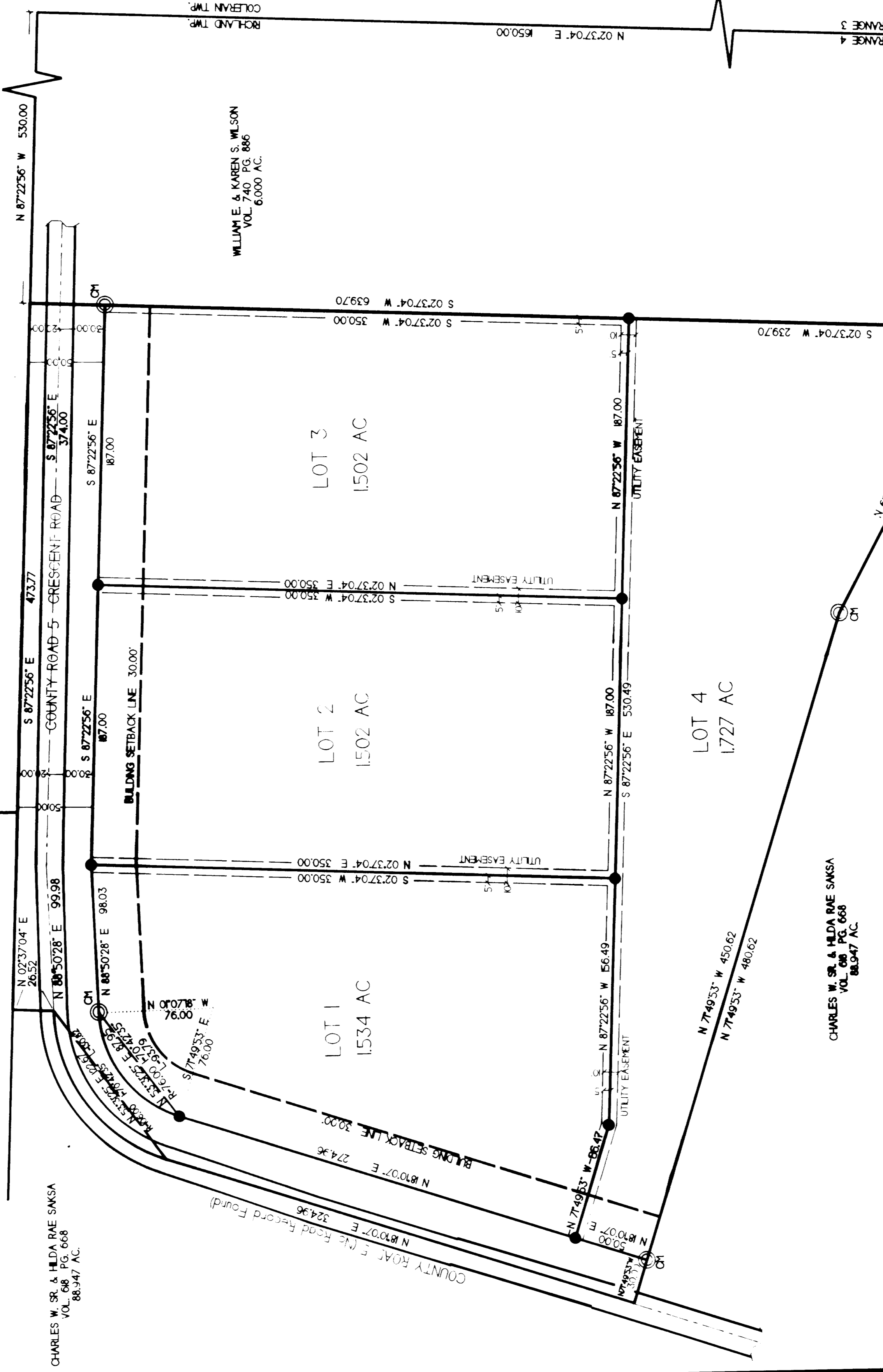

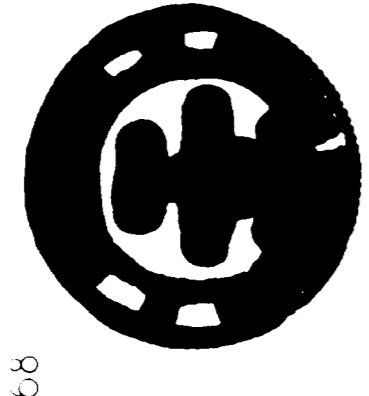
EAST LINE OF SECTION 6
