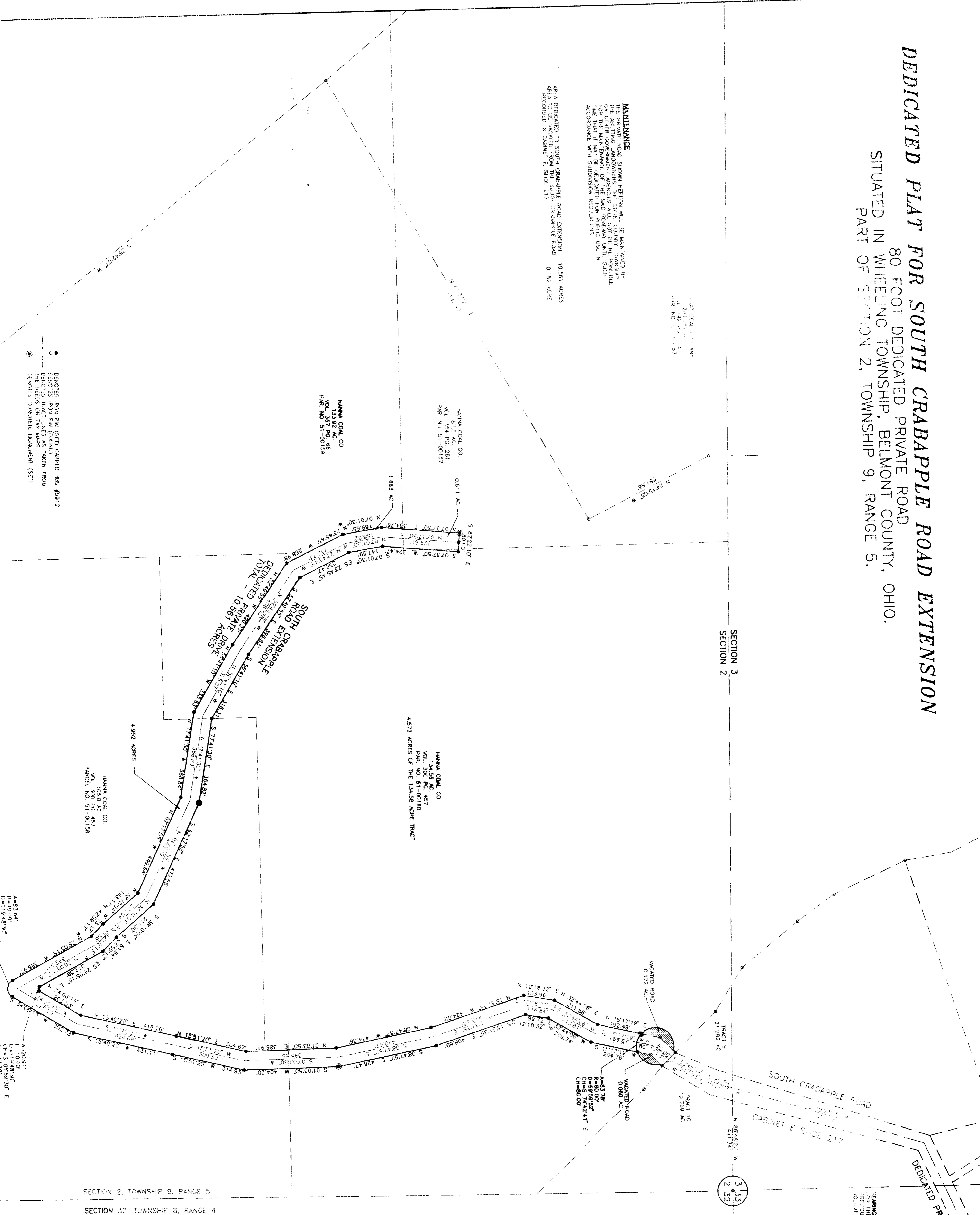


# DEDICATED PLAT FOR SOUTH CRABAPPLE ROAD EXTENSION

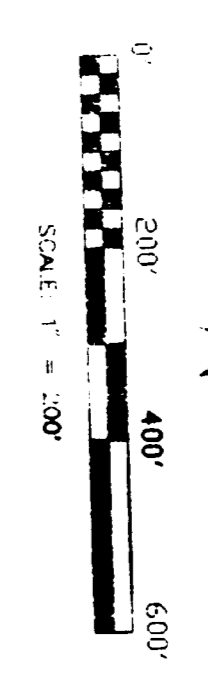
80 FOOT DEDICATED PRIVATE ROAD
