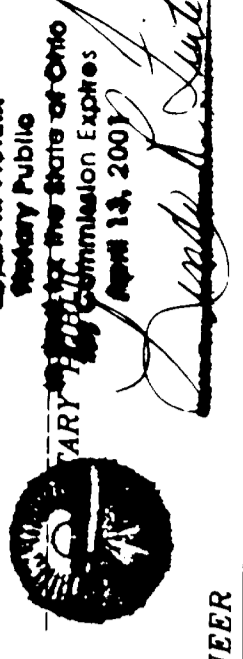
OWNERS CONSENT AND DEDICATION
