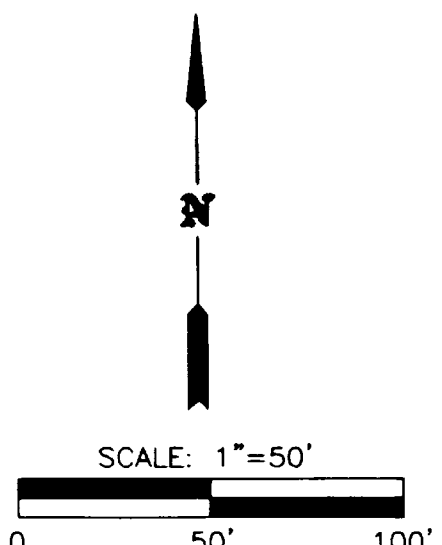
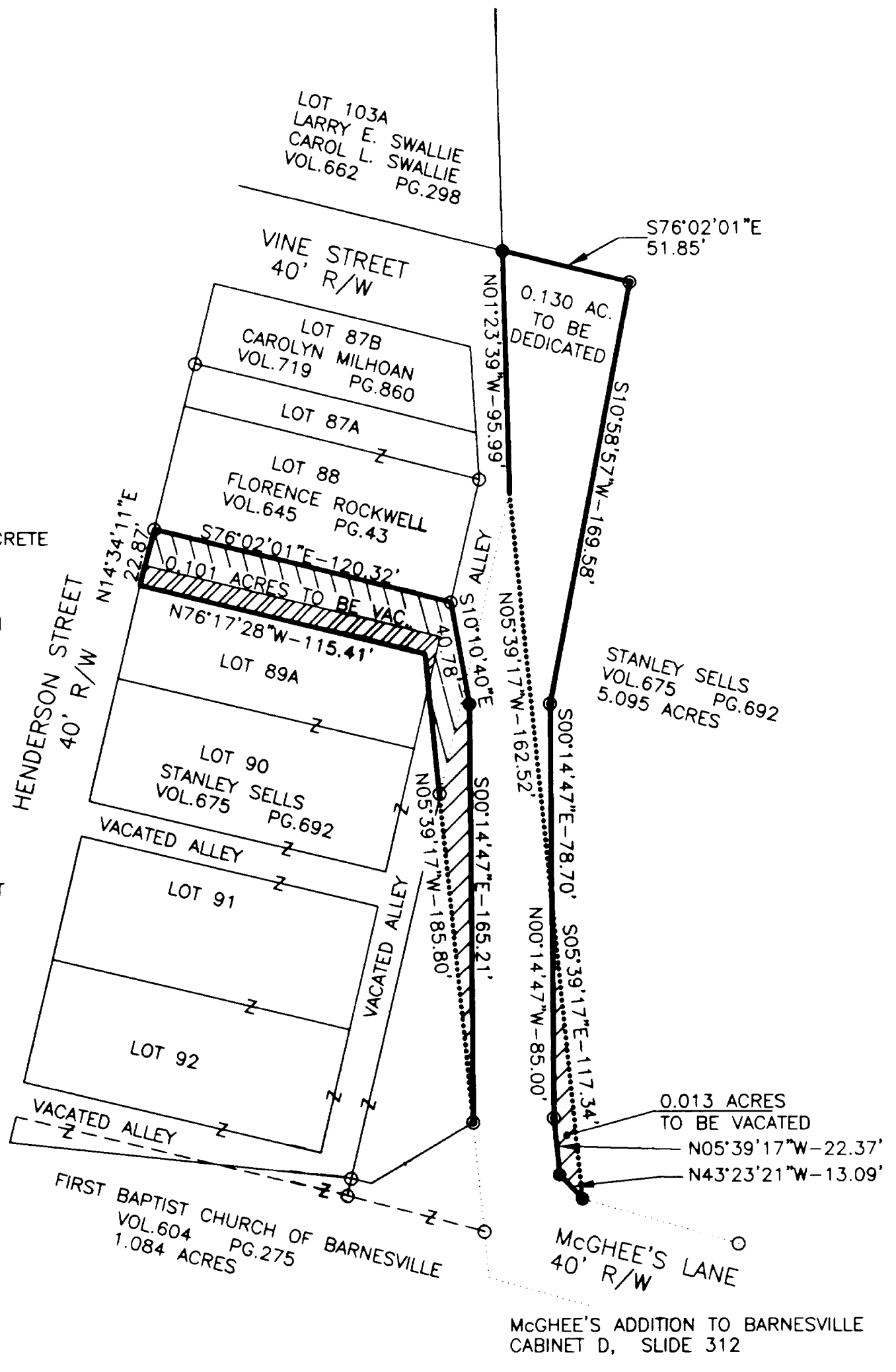


McGHEE'S LANE DEDICATION & VACATION PLAT VILLAGE OF BARNESVILLE

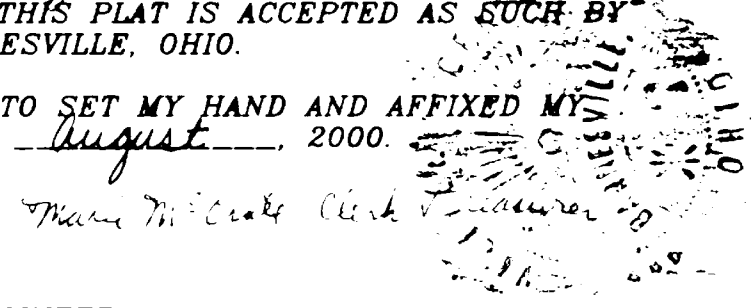
