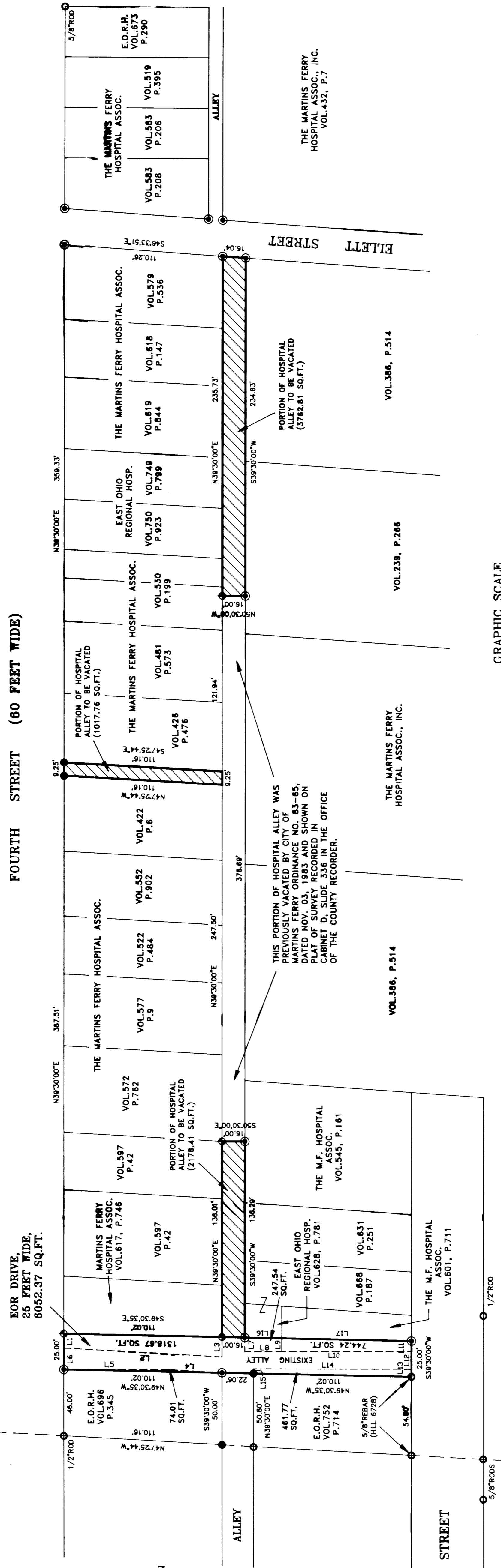

OWNER'S CONSENT AND DEDICATION:

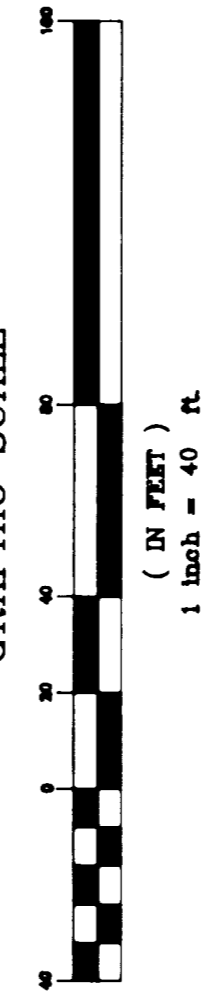
