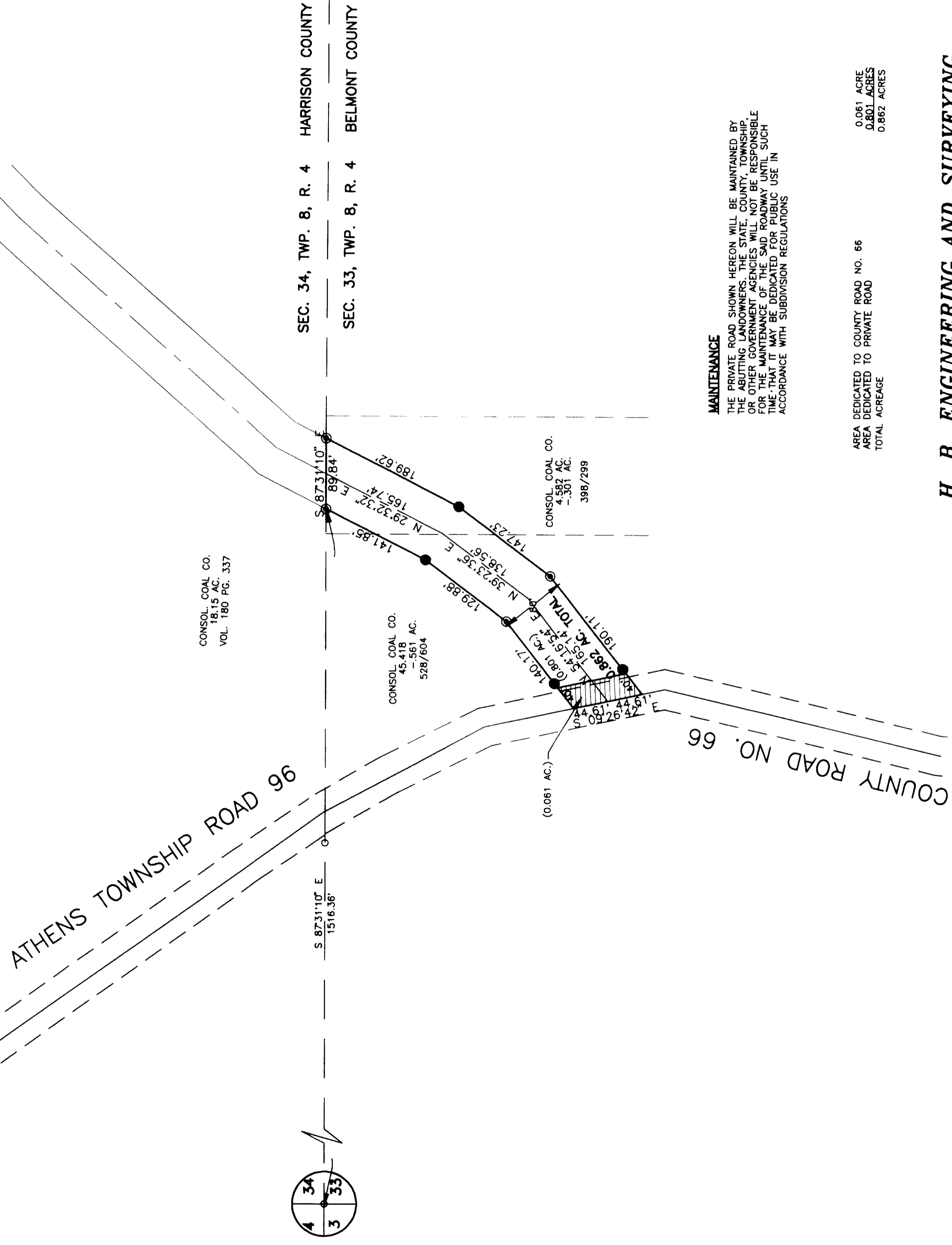


DEDICATED PLAT FOR JAY ROAD

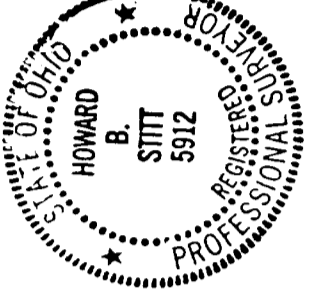
